COMMUNITY HEALTH NEEDS ASSESSMENT IMPLEMENTATION PLAN 2013

Pershing Health System is the leading health provider for Linn County and seeks to provide a full continuum of primary and secondary healthcare services for all residents of our service area. The primary aim of our Community Health Needs Assessment is to improve the overall health of Linn County through identifying any areas of need and secondly to engage key stakeholders in the county for their input on health vulnerabilities. Moving forward with the implementation plan will merge our organization's key strengths, our mission to serve others through quality, compassionate care and the engagement of community stakeholders as we address these vulnerabilities and unmet needs within the community.

Pershing Health System is addressing or in the process of addressing each of the primary needs identified in the Community Health Needs Assessment. The focus areas that Pershing Health System has selected to address as priorities are Helping Children in Poverty, Addressing Adult Smoking, Addressing Adult Obesity, Increasing Access to Mental Health Providers and Services, A Lack of Primary Care Access and Physicians, and Medication Education. Pershing Health System realizes that other areas of unmet needs are clearly important to improving the health of the community, however, these areas of unmet needs have been determined to either have a less immediate impact, will be addressed in a future plan, or require resources beyond Pershing Health System's scope of service.

Pershing Health System considered available data, population affected, and seriousness of each primary need identified in the Community Health Needs Assessment to determine the most significant health needs of the community. In addition, Pershing Health System factored in its' available resources and community partners in selecting our priority health issues.

PRIORITY #1: HELPING CHILDREN IN POVERTY

The ability to pay for healthcare services is key to accessing health services resulting in better health outcomes of the individual. Linn County is well below average in its mean family income of \$51,231 compared to the U.S. mean family income of \$82,446. 2007 data obtained from www.kidscount.org indicates 22% of children in Linn County live in poverty compared to 18% in Missouri and the nation.

CONTRIBUTING FACTORS TO HEALTH ISSUE:

The health of the youth population is vital to the future health of the overall population. Studies have shown that there exists a strong correlation between childhood obesity and adult obesity. There are also key indications that obesity is more prevalent among the lower socioeconomic population.

THREE YEAR GOAL FOR IMPROVEMENT:

Pershing Memorial Hospital will provide increased opportunities to assist children and families in poverty to receive health care education and services during the next 3 years through provision of

wellness exam events, increasing accessibility and community awareness of the PHS Financial Assistance Program, and participation in community events to promote positive health behaviors for children.

BUDGET FOR HEALTH ISSUE:

A budget of \$1,000 has been allocated for this priority. Direct costs include supplies and advertising. Indirect costs include staff time for the event and operational expenses.

PRIORITY #2: ADULT SMOKING IN LINN COUNTY

2012 data obtained from www.countyhealthrankings.org, indicates 27% of Linn County residents were estimated to currently smoke every day or “most days” and smoked at least 100 cigarettes in their lifetime. Comparatively, Missouri residents identified at 24% and the National Benchmark is 14%. The rate of adults that smoke in Linn County exceeds the rate of smokers in the state and in the nation.

CONTRIBUTING FACTORS TO HEALTH ISSUE:

Adult smoking is a health behavior that negatively impacts the health of individuals and communities. Each year thousands of premature deaths occur primarily due to smoking and it is identified as a contributing factor to multiple diseases such as cancer, cardiovascular disease, and respiratory conditions. Web-based and telephone smoking cessation programs are currently available to residents of Linn County.

THREE YEAR GOAL FOR IMPROVEMENT:

Pershing Memorial Hospital will offer adult smoking cessation programs beginning in the fall of 2013 in effort to reduce the rate of smoking in Linn County.

BUDGET FOR HEALTH ISSUE:

A budget of \$1,000 is allocated for this priority health issue. Direct cost includes obtaining certified facilitator training for PMH staff, advertising, and participant supplies. Indirect expenses include staff time and facility operational fees.

PRIORITY #3: ADDRESSING ADULT OBESITY

Adult obesity is becoming an epidemic in the U.S. and increases the risk for countless health conditions. Pershing Memorial Hospital employs a registered dietitian that provides nutritional services to the patient population. Opportunities will be explored through Pershing Health System and community stakeholders to plan for general public use and access to nutritional and dietary education.

CONTRIBUTING FACTORS TO HEALTH ISSUE:

Obesity is an energy imbalance due to a lack of physical activity combined with a poor diet. Obesity can ultimately lead to the following: coronary heart disease, Type 2 Diabetes, cancer, hypertension, stroke, gall bladder disorders, respiratory problems, and osteoarthritis. In 2012, Linn County adult obesity was identified at 37% with the Missouri rate of 31% and the National Benchmark of 25%.

THREE YEAR GOAL FOR IMPROVEMENT:

Pershing Memorial Hospital will increase accessibility and opportunities for health education programs for adults that include education for healthy nutritional and physical activity habits in the next 3 years to decrease adult obesity in Linn County.

BUDGET FOR HEALTH ISSUE:

A budget of \$500 is allocated for this health priority. Direct costs will include advertising and promotional products. Indirect expenses will include staff time and facility operational expenses.

PRIORITY #4: INCREASING ACCESS TO MENTAL HEALTH PROVIDERS AND SERVICES

Unfortunately as is common in most rural areas, Linn County has a lack of mental health providers and services. Pershing Health System does not have the resources that would be required to effect the changes that are needed to completely address the lack of mental health care and access to mental health providers and services. However, Pershing Health System will utilize available resources to participate and engage with community agencies and initiatives to enhance relationships among community stakeholders and consumers of mental health care to increase awareness in responding to mental health crises and improve continuity of care for mental health consumers.

CONTRIBUTING FACTORS TO HEALTH ISSUE:

2012 data from www.countyhealthrankings.org illustrates that Linn County residents report a greater number of poor mental health days than the Missouri and National benchmarks. Linn County is significantly lacking in mental health providers for their community compared to the state of Missouri.

THREE YEAR GOAL FOR IMPROVEMENT:

Over the next three years, PHS will increase participation with community agencies and initiatives that provide awareness of mental health issues and continuity of care for mental health consumers in effort to improve the overall well-being of Linn County residents.

BUDGET FOR HEALTH ISSUE:

Costs associated with this priority will include indirect expenses of staff time.

PRIORITY #5: A LACK OF PRIMARY CARE ACCESS AND PHYSICIANS

A shortage of primary care physicians is always an issue in rural America and Pershing Health System is striving to improve the access for county residents. Pershing Health System lacks the resources to make immediate changes to influence the lack of primary care access and physicians. Pershing Health System will continue established relationships and efforts to maintain, encourage, and secure primary care access and physicians in Linn County. Pershing Health System is a participating organization in the Primary Care Resource Initiative for Missouri (PRIMO). Pershing Memorial Hospital currently supports two students in medical school through scholarship/sponsorship and will employ them upon completion of their residency. Pershing Health System is continually recruiting family practice physicians and nurse practitioners to the area to provide inpatient consults and primary care and will continue to do so in the foreseeable future. Pershing serves as a preceptor site for medical students and NP students from A.T. Still University and University of Missouri/Columbia.

CONTRIBUTING FACTORS TO HEALTH ISSUE:

Linn County like many other rural counties is facing a shortage of primary care services. Primary care shortages are usually seen in Missouri’s less populated counties where doctors, dentists, and other providers are likely to be few and far between.

THREE YEAR GOAL FOR IMPROVEMENT:

PHS will provide increased opportunities to educate the community of health care careers over the next three years.

BUDGET FOR HEALTH ISSUE:

A budget of \$250 is allocated for this health priority. Direct costs will include advertising and promotional products. Indirect expenses will include staff time and facility operational expenses.

CONTRIBUTING FACTORS TO HEALTH ISSUE:

With a growing number of patients taking long-term medications education about certain types of medications are vital to insure the health and safety of newly diagnosed patients with long-term illnesses.

THREE YEAR GOAL FOR IMPROVEMENT:

Pershing Health System will develop community medication education campaigns during the next three years to increase community awareness of medications.

BUDGET FOR HEALTH ISSUE:

A budget of \$250 is allocated for this health priority. Direct costs will include advertising and promotional products. Indirect expenses will include staff time and facility operational expenses.
